#### **New Business**

## 1. Heat Pump Press Release

The Task Force reviewed the press release for the heat pump installation. Erin will email this press release to Melinda McKnight to review and edit her quote.

## 2. Posters for Solar Array and Heat Pumps

Lynne shared drafts of posters about the solar array. The CSTF will comment on options. Lynne will work on a heat pump poster and an additional educational poster based on the GHG inventory to post on the wall near the town clerk's office. These will be ready by April 12.

Lynne and Felicia are reviewing other green building policies and will add these examples to our shared drive. Erin will draft a policy to share with the CSTF by April 30.

Lynne and Kristen shared that we don't have a purchasing policy in the town that is written out as far as we know, but we have an example from Hastings on Hudson to work from. Erin and Kristen will review this draft and add anything that's missing (including adding locally sourced guidelines).

## 1. Social Media Policy

#### 2. CSC Points Review

We need a minimum of 120 points to receive bronze certification and the action items that the task force is currently working on total to 162 points. There are a few actions including the unified solar permit and fleet policy that might not be doable by the deadline, but the CSTF is confident we will be able to achieve close to 140 points and achieve bronze certification in case we do not get awarded full points for any action.
