- Kristen will get permission from Mike Boms to have 10 min presentations at 3 board meetings
- Kristen to reach out to Tom Konrad to see if he could give a presentation on community solar and we could perhaps do a presentation as part of a town board meeting (hopefully we could have someone record that presentation so that we could use it again)
- Kristen to talk to 2 other speakers from the Ulster Campaign group to see if they're available for the board meetings in February (13, 27) and March (12 or 26).
- Put out another mailer February 1 that promotes these meetings as well as the program in general
 - Erin and Lynne to help write this once we know speakers
- Peter installed Lennox heat pumps with JSP, so his installation will count towards our numbers
- With EVs we have a state registry we can use to look up everyone in our town who has purchased a vehicle post 11/29/23.
- Peter will reach out to JSP to see if they have a list of customers in Hurley, West Hurley.
- Peter will ask the buildings department to keep us informed if people are applying for permits that indicate they're getting heating pumps (permit for fuel tanks being removed, permits for electrical upgrades etc.).
- After this campaign we could do our own solar rooftop campaign.
- Erin to reach out to HWS to see if they keep a list of people who got heat pumps in Hurley
- 2. Hurley Solar Law reconsidered
 - a. Peter talked to Mike Boms about this and he is open to working on a new law! Peter is going to start working on this with the Zoning Task Force.
 - b. Stephen will help advise on this based on his experience with zoning and solar laws and will send Peter a model solar law.

- c. Perhaps this law can include guidance on using the new SITED act or Scenic Hudson's How to Solar Now solar tool as a resource
