Hurley Solar Law reconsidered

- The planning board could be given more discretion
- NYSERDA put out a model solar law that we can use to try to update our law to be less restrictive
- We could make a report from the Climate Smart Task Force to the town board on our recommendations using the analysis from NYSERDA we received when applying for Climate Smart
- Kristen will send the analysis from NYSERDA to Peter to look into how we might approach this with the board
- We would also get Climate Smart points and Clean Communities points for instituting this
