- Onteora Central School District presented their proposed 2019-2020 budget. a. The increase is \$1825919. or 3.28% b. The three part budget consists of 7.22% for Administrative, 8.85 for Capital and 83.92% for programs. c. Capital projects funded with the budget are Chemistry Lab \$272,000 and Press box/bleachers for \$478,000. The Budget vote will be May 21 from 2PM to 9PM at the Bennett, Phoenicia and Woodstock Schools.

- 3. Several residents near the former Twin Lakes Lodge voiced their concerns over a proposal to redevelop the property into a upscale hotel and camping sites.
