Town Board Business

- 1. Two representatives spoke on this year's Onteora School budget. Copies were left at the Town Hall for anyone interested. If you have any questions call Leslie Ford Superintendent at 657-8851 or go to their website.
- 2. Supervisor Bellows advised everyone that you can go online to census.gov/2010census to print the forms for the census.
- 3. The town is in negotiations with property owners for the drainage in Rolling Meadows. Eagles Nest needs to be done ASAP. Hook and Walnut will advertise in May or June. The money is already set aside for these projects. Ohayo Mt and Bristol Hill still has money from CWC.
- 4. The county may take over Safety Net. We are the only county in the state where the county has not taken it over. Our Social Services Rep goes over each bill to verify residency.
- 5. Rail Trail Issues: The dog walk for dogs that need adoption would need a special use permit approved by NYS with 3 months notification. The Rail Trail Mixer will be June 5 from 9-1. The DEC may have to trap the beavers on the rail trail so we can dig down to get the water off the trail.
- 6. Councilman Gill spoke to Dave Corrigan and he granted us permission to put up the gazebo by the parking lot on the rail trail. The trail committee wanted it to be a natural color but it only comes in white or ivory and is 10 feet. Since the Lions club budget ends on 6/30 they need to know soon if the town wants to move forward.

The Highway Superintendent sent down his agreement for Expenditure of Highway Moneys. There are some mistakes and it needs to be reworded. Since Broad St. needs paving right away and the money is in the budget for it we will go ahead on Board St. and have the new agreement at the next meeting.
