## **Town Board Business**

1. Memorial Day parade is chaired by Debbie Oakley. They have picked a grand marshal and that will remain a secret for a while. If anyone would like to volunteer please contact Debbie Oakley or call the supervisor's office.

2. In today's email we received from Clyde, a high way 2009 road plan and I would like the town board members to look that over and by the next agenda meeting have questions for Clyde, and if we all agree, pass it at that time.

3. Councilman Gill will set up a meeting with the West Hurley Fire commissioners about the blacktop at the basketball court.

4. We got a letter from Sen. Bonaic about our grant for solar panels. It was unfrozen on the  $8^{th}$  then got refrozen on the  $17^{th}$ . Supervisor Bellows would ask if anyone feels like they would like to write to the governor in support of the Town using this grant for solar power and that the grant should be unfrozen.

5. Upon further review with the OWB Attorney Darwak found that some parts of it were not defensible in court so he is going to re-write parts and give it to the town board to review 6. Supervisor Bellows received a letter about having the Town of Hurley emblem over the Hudson when they have the sail. Councilwoman's Horner will ask her daughter who designed the original Hurley emblem if she would like to do it.

7.Ellen Cordaro was appointed as the Assessor aid at the Agenda meeting.

8. Councilwoman Hyman said that they were awarded the grant for the Central Catskill Col. It was for \$50,000. This is for the route 28 corridor to turn it in to a scenic byway for tourism. Each town is responsible for submitting something about it and they will be doing a tourist map.

9. Councilwoman Hyman handed in a worksheet for the Lower Esopus group for her in kind time that was spent. We had to come up with 14,000 of in kind time. Supervisor Bellows put in his sheet as well as his secretary so I think we hit the 14,000.

10. Supervisor Bellows received from the judges a flyer about the panel doors to separate the court room. If the town board would over the info we will make a decision.

11. The NYS DOT Hurley walkable was not selected unfortunately but we do have the \$20,000 from a previous grant. We thought that what we would do is go in and at least start the parking area and use these grant dollars before we lose them. So we have a resolution from Brinier and Larious to allow us to do work on the NYS DOT right of way.

12. There is a piece of land that is being considered for acquisition from the NYC DEP and we 120 days to respond.

13. Dieter Harms who had worked on a zoning revision committee came to the town board and had asked about starting some additional work and mentioned that it should be dove-tailed in with the comprehensive plan. Supervisor Bellows is going to get Dieter together with Ruth Wahtera to discuss this.

14. Hook and Walnut easements were all set to go and then we found out that one of the houses sold and that the new resident had no idea about the easement. That easement had to be changed and Brinier and Larious and Jack Darwalk had to talk with the new resident and get them to go along with the program. As soon as that is done we will be having a meeting at the town hall for all the residents and get the signatures.

15. Supervisor Bellows received a call from the office of the aging they had asked us to support if they were to open up an office in Woodstock. The town board agreed that Supervisor Bellows write a letter of support so that they would have a better chance with the legislative.

16. We had a letter from Paul Economos regarding the Letersky property. This is a person that bought residential property in Old Hurley and now they want to put horses there. When they first went before the planning board there was talk of a riding stable. This could lead to spot zoning. Supervisor Bellow is going to talk to Jack Darwak about this and get back to the board.
