#### **New Business**

- Next meeting of Town Board will be at 6 p.m. Thursday, April 18, at Town Hall (instead of Tuesday, April 23)
- Hurley Heritage Society Raleigh Green talks about group being made up entirely of volunteers, holding fundraisers to supplement small grant, upcoming events to mark group's 50<sup>th</sup> anniversary (Rooster Auction on June 7, Hurley Heritage Day on Sept. 21, Gala Dinner on Dec. 6)
- Town Clerk's Office hours Kellogg talks about being open some evenings and weekends, and holding hours on Saturdays at the Transfer Station
- Employee Handbook Last revised seven years ago; HR Visions tasked with updating
- Financial Committee James Quigley wants two members of Town Board included; Boms suggests Kelly and Simpson

- Town Audit Boms says accounting books have been in disarray (last accurate records are from March 2023), Town is behind in submitting 2023 records to state (state has OK'd delay, will probably be asked for additional time), working on 2024 records now; Kellogg says all 2023 payment records are current but not all 2023 bills have been paid
- Resolutions given to Town Board members to review before voting on them at next meeting

### **Old Business**

- EMS Dougherty says she's meeting with fire department chiefs, EMTs, representatives of nearby towns (i.e. Marbletown, Olive); will meet with Empress and Northern Dutchess Ambulance; Hurley might have to go with paid service; addressing concerns about road safety
- Greenway Environmental Services/Zero Waste Boms says he's received both complements and criticism, notes that contract cost was set in 2023
- Leachate pulls Town has cut \$46,000 cost to \$13,000 by using UCRRA
- Banking Obtaining better interest rate is earning Town \$500,000 instead of \$125,000
- Landfill cleanup RFQ for work issued by Crawford & Associates
