Meeting called to order at 7:00 by Supervisor McKnight

1. Public Comment –

- ✓ Sam Magarelli Woodstock Volunteers Board member shared the importance of volunteer work in creating community, thanked Hurley volunteers, especially the Wet Hurley Fire Department, and invited the Town Board and Hurley residents to attend Woodstock's Annual Volunteer Day celebration on August 19th
- ✓ Matthew & Aileen Henlsley—reported that the drainage issue on Altamont Dr has been resolved and thanked Supervisor McKnight and Highway Superintendent Shultis for their professionalism and commitment.
- ✓ Chris Moore Orchard St. reported ongoing flooding and ground saturation issues on his property and his neighbors. He's had flooding in his basement and his septic is filing up with water. He believes it's an issue with the culverts. He stated that communication with the town has not been timely. He asked when the easement letters were going out so that a survey could be conducted to determine the cause and define the solution.
- ✓ Diana Cline Fairview Ave, asked if there was going to be a clerk's report. She also asked why Councilmember Humphries isn't report mileage when using his personal vehicle. She asked if there was a mileage policy for the town.
- ✓ Raleigh Green Mountainview Ave, there was a power outage in Rolling Meadows is there an update on cell service improvements in Hurley. He mentioned that the Bonadio has offices in Rochester and NYC and suggested that the town use local services.
- ✓ Kathy Dolan Wildwood Dr, asked for an update on the Wildwood Dr. RFP.
- ✓ Lynne Bailey Walton Lane, has experienced basement flooding and asked if a berm could be installed to divert the runoff away from her home. She asked if anyone in the Building Department had received an invitation to the public meeting on May 1st by Jordan Bem and Arizona Hudson Valley.

- ✓ Memo from Brinnier and Larios P.C. regarding speeding solution for Joys Lane suggesting speed bumps be installed (posted at tinyurl.com/bdjvr2ec)
- ✓ Highway Superintendent Shultis asked the town to purchase temporary speed bumps for Joys Lane to test whether this would be a permanent solution for speeding He also suggested that the temporary speed bumps could be use on other roads. All in favor
- ✓ Superintendent Shultis inquired about the purchase of a backhoe
- ✓ Superintendent Shultis requested legal advice from the town attorney. He stated that town attorney could not offer services as he was attorney to the Board an it would be a conflict of interest.
- ✓ Superintendent Shultis inquired about \$7824 charged to his budget line, he also reported that everything is completed for the RFP for Wildwood, he inquired about the Chambers and Simpson easements are.

4. Highway Report

- ✓ Superintendent addressed Supervisor McKnight and Town Attorney Andrew Lessig asked to utilize legal services from Town Attorney for interdepartmental conflicts so that attorney fees would not come out of the Highway budget. Attorney Lessig stated that his firm worked for the entire town and that it would be a conflict of interest for the firm to advise one department against another.
- ✓ Mr. Shultis stated that he needed more communication and said vouchers need to be available to the pubic
- ✓ Mr. Shultis stated that his vouchers for items he purchased with his personal funds have yet to be reimbursed and asked if and when they will be.

5. Other Business –

- ✓ Motion to accept draft minutes from August 1, 2023 meeting offered by Councilmember Martin, Seconded by Councilmember Boms.
 - All in Favor
- ✓ All vouchers now being paid in-house
- ✓ ADP is processing payroll through Samara Genee, Executive Assistant to Supervisor McKnight
- ✓ Councilmember asked where the 4 town cars are being parked, who is doing the maintenance and cleaning, and why there aren't town logos on the vehicles
- ✓ Councilmember Humphries proposed that the Town establish a "Volunteer appreciation Day" in Hurley to recognize all the wonderful volunteers
- ✓ Councilmember Humphries reported that there has been deliberate vandalism at Dug Hill Park restrooms and that the leachate pump wires had been deliberately cut
- ✓ Supervisor McKnight reported that she has had ongoing meetings with the county regarding installing additional cell towers in Hurley to improve cell coverage; one will be at Wynkoop and 209 and the other will be an upgrade to the system in the Hurley Reform Church belfry. Six new tower installations are planned in Ulster County over the next 2 years.
- ✓ Councilmember Boms asked if there was a maintenance person yet and if the town was going to have UCRRA do the leachate pulls.
- ✓ Councilmember Humphries proposed that Hurley have a Volunteer's Day similar to the one in Woodstock. He reported that there has been vandalism at Dug Hill Park. Someone had turned the water pressure flow down to the toilets and someone cut the electrical cord to one of the pumps at the leachate field.
- ✓ Superintendent Shultis asked why the town cars don't have signs on them identifying them as town cars and cameras and GPS like the highway vehicles.
