WEREAS, the Ulster County Planning Board responded with comments supportive of the draft Local Law, and he Town of Hurley Planning Board provided no response; and

WHEREAS, on July 26. August 16 and August 23, 2021, a public hearing on the draft Local Law at which all those who wished to be heard were permitted to speak or submit written comments; and

WHEREAS, the Town Board has thoroughly reviewed the potential environmental impacts of the draft local law, considered the comments of all interested and involved agencies and the public; and reviewed and completed Part 2 of the FEAF;
