WHEREAS, the Town of Hurley has maintained a Transfer Station since the Landfill was closed; and WHEREAS, the Town of Hurley is dedicated to maintaining a Transfer Station to dispose of and recycle waste for the citizens of the Town; and

WHEREAS, previous Town of Hurley Town Boards set a policy that the Transfer Station should operate without a profit; and

WHEREAS, the Town of Hurley has made little to no investment in safe, efficient operation of the Town of Hurley Transfer Station; and

WHEREAS, in _____, ____ the Town Board adopted Resolution # _____ which allowed employees at the Transfer Station to collect glass and metal recycling and receive half of the proceeds because the wages they were paid was very low; and

WHEREAS, Resolution # resulted in incentivizing some employees to focus on collecting items from which they would profit instead of performing the responsibilities for which they were hired; and

WHEREAS, the daily operating procedures were the subject of an Audit by the New York State Comptroller's Office in 2019-2020; and

WHEREAS, the Audit has resulted in additional investigations by other State and Local entities; and WHEREAS, the Town Board has discovered that it has failed to realize hundreds of thousands of dollars over the past ten years due to these practices; and

WHEREAS, the Town Board wishes to bring the Town of Hurley Transfer Station into compliance with the rules and regulations of "Good Government" as outlined by the New York State Comptroller's Office; and

WHEREAS, the changes have resulted in additional revenue to the Town of Hurley that the Town Board wishes to invest in the proper, orderly and efficient operation of the Transfer Station; and WHEREAS, the current Transfer Station staff have already saved the Town of Hurley tens of thousands of dollars by repairing the Leachate System, snow clearing during inclement weather, and identifying and implementing policies and procedures to improve efficiencies; and

WHEREAS, the current Transfer Station staff work in an environment without proper shelter, a functional restroom or hand-washing station, are essential workers subjected to temperature extremes, and are often subjected to various forms of verbal abuse by members of the public; and

WHEREAS, the Town Board values our essential workers and wishes to recognize all that they do for our community and our country; and

WHEREAS, the Ulster County Resource Recovery Agency has announced that where our waste is transferred to will be closing and all policies and procedures for waste disposal will be changed and mandated by Ulster County thus requiring more staff time to be devoted to implementing a "Zero Waste" strategy in each town; and

WHEREAS, due to the updated operating procedures, increased usage, volume and maintenance, more employee time is needed to maintain a safe and efficient operation; now

THEREFORE BE IT RESOLVED, to change the status of the Transfer Station Department Head, Deputy Department Head and two (2) essential employees from "part time" to "full time" status and to receive the applicable benefits and rights as defined in the Town of Hurley Employment Handbook, retroactive to February 1, 2021.

WHEREAS, the front line personnel at the Town of Hurley Transfer Station are considered Essential Workers and the Town of Hurley wishes to recognize their hard work and dedication working through the pandemic, now

Catskill Mountain Byway Seconded by Councilman Boms

WHEREAS, the Catskill Mountains Scenic Byway (CMSB), consisting of portions of State Routes 28, 214, and 42, spanning 58 miles and involving six municipalities, was signed into law by the Governor in 2015; and

WHEREAS, the Central Catskills Collaborative, comprised of representatives from each municipality, have worked together successfully to develop the scenic byway nomination and promote the region through numerous tourism and partnership efforts; and

WHEREAS, the CMSB Corridor Management Plan identifies the intrinsic values that comprise the special designation and includes recommendations to protect and enhance the historic, scenic, recreational, and cultural resources along the CMSB; and

WHEREAS, the CMSB, along with the Mountain Cloves Scenic Byway (MCSB), have formed the Joint Byway Group, and have worked cooperatively to expand the scenic byway system in the Catskill Region; and

WHEREAS, the town of Hurley has expressed interest in establishing a connection with the CMSB and extending this byway along the Routes 28 corridors; and

WHEREAS, the town of Hurley has many intrinsic qualities and special resources that will enhance tourism promotion, economic activity, and strengthen regional cooperation with other byway communities; and

NOW, THEREFORE, BE **IT** RESOLVED that the town of Hurley supports extending the CMSB within the town on State Route 28 and will appoint two people and/or a small committee to assist **in** the inventorying of intrinsic resources and serve as advisors to a consultant who will develop a revised CMSB Corridor Management Plan; and

BE **IT** FURTHER RESOLVED that the town of Hurley will work with the Central Catskills Collaborative and CMSB partners to explore opportunities for cooperation and methods to advance the extension of the CMSB.
