"Over the course of recent weeks and months it has become apparent that the plans and goals of Hurley 209 LLC (and its project associates), the prospective purchaser of the 400+ acres owned by Gill Family Association LLC in Hurley, have changed in a way that is less beneficial to the Town's needs, at variance with the overall intentions of the Gill Family, and contrary to the terms and conditions originally expressed between the parties to the original contract.

The purchaser has expressed its doubts and, we believe, wavered in its commitment to the original agreement in ways that required us to present it with an ultimatum to perform as agreed. It responded by withdrawing from its contractual obligations. Consequently, the sale contract

From Gill Family Associates LLC to Hurley 209 LLC, which was the basis of the application pending before the Hurley Planning Board for the project known as "Hidden Forest at Hurley

Subdivision", has been [has] terminated.

It is our understanding that the purchaser and its associated companies have submitted, or will soon be submitting, to the Planning Board the paperwork which officially withdraws the application for such approval."
