- •A. Supervisor Shultis explained that Onteora Central School is considering options for the use of the Ryan building at the closed West Hurley school campus. The future Onteora options are (1) create a central campus at Boiceville, (2) close one of the elementary schools or (3) keep all three elementary schools open. If the Ryan building were to be surplused Supervisor Shultis asked if the Town Board favored a presentation to Onteora presenting the Towns interest in acquiring the building.
- B. Frank Machung asked to use the Town Hall to hold free AARP Tax Assistance on Mondays or Tuesdays during March and April. He also asked for the use of a phone to have someone schedule these appointments. The Board agrees to the use of the hall but is not agreeable to providing an assistant or phone.
- C. The Recreation Committee has met three times to develop future plans for the expansion of the park. These plans include the addition of an extra pavilion, baseball field and tennis court. Diane Cline added that the Rec. Comm. will also revamp the bus trip reservation process.
- D. The Planning Board has been asked to make an Aappropriate density@ commendation for the AHidden Forest@ project.
