- 1. A letter from Robert Brundage was received regarding Local Law # 7 Historic Preservation. After receiving a second letter, the Town Board would like a chance to review the information and will have more discussion at the February meeting.
- 2. A resolution was made at the Agenda meeting to change Judge Corrado's salary. A mistake was made at the organizational meeting and her salary is now up to the correct amount of \$15,250.00.
- 3. A Town Hall dedication plaque will be mounted in the Town Hall.
- 4. A letter came from NY DEP Land Acquisition Program for a request of the 22 acres that run from Route 28A and Baker Road. A memo was sent out to the Panning, Zoning, CAC, Assessor, Town Board and our lawyer to ask if there was any reason to disagree

- with this acquisition. Supervisor Bellows is waiting for those responses. The information is posted on the bulletin board if anyone interested in this acquisition.
- 5. After talking with Attorney Darwak about the Williams Lane Terminus everything seem to be in order and the Town will be ready to take over the terminus by February.
- 6. Supervisor Bellow received a copy of the letter that the Park Grant was denied on 11/30/07. We will be looking for new grants as they become available.
- 7. Time Warner sent a letter about dropped channels. It will be posted on the bulletin board along there scholarship program which has a deadline of 4/8/08.
- 8. Resolution for the tractor bid was passed at the Agenda meeting and the bids will be opened on February 19th Agenda meeting.
- 9. Don Beesmer was reappointed to Planning Board until 12/31/2014
- 10. Councilman Gill spoke to Jack Darwak about the transfer of the Hurley Library to the Library Board. There is a question about the legality of how it was done. After sending the resolution to the Association of Towns we need to get a judgment from them and possibly from the controller's office about how it was handled. Councilman Gill will report back as he gets more information.
- 11. Three highway employees are signing up for Highway Uniforms. Supervisor Bellows, Superintendent Russell, the Labor Relations Rep and the Director of the Union are to sign off on this agreement. Other highway employees can sign up at a later date.
- 12. NY Alert numbers will be posted on the bulletin board for anyone interested in signing up for this program. They will alert you by email or cell phone of situations in your neighborhood. Ex: floods or hazards in your neighborhood.
- 13. After meeting with the attorney, Millbrook Ave is at a standstill until we get proof of ownership. On the record the property is not owned by the Letersky's.
- 14. Supervisor Bellows asked Highway Superintendent Russell to come up with a plan to keep Main St sidewalks and Rail Trail clear.
- 15. Article 78 was filed by the OWB. After speaking to Attorney Ragus, he has agreed to complete this litigation for the Town.

FROM TOWN BOARD MEMBERS AND DEPT. HEADS

Councilwoman Briggs: 1) Hazard Mitigation Plan -The Town has been invited to join the Hazard Mitigation Group. In joining this group we will be eligible for any Fema funds. The Town board needs to put together a resolution to become an active member.

2) Historic Preservation Committee: All the member terms have expired. We want to reinstate this committee and hopefully get people from West Hurley and old Hurley.

Councilman Gill: We received letters back from all three candidates for building inspector. Supervisor Bellows will be contacting them to set up interviews.

Emergency Mgt Plan: Councilman Gill spoke to Phil Singara Jr. about setting up a meeting with all depts. and what training has to be done. We found out that every employee of the Town of Hurley has to be trained and certified. A workshop will be setup with the Fire dept. that will be doing the training and the Town Board as soon as possible.

Bill Brinnier read the proposed amendments to the Zoning Law of the Town of Hurley. Copies of the changes are available at the Town Clerk's office.

James Craven: MSW for 2007 was 672 tons a drop from the previous year. Recycle has increased 31 tons.
