AGREEMENT between the Town Superintendent of Highways of the Town of Hurley, of Ulster County, State of New York and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, the revenues from equipment rentals, reimbursement for snow and ice removal and other charges for services, the reappropriated funds, and the CHIPS and other State aid for highways, shall be expended as follows:

- IA. GENERAL REPAIRS. The sum of \$336.955.00 shall be set aside to be expended for basic work and general maintenance and repairs upon 52.46 miles of town highways, including sluices, drainage ditches, culverts and bridges having a span of less than five feet, tree and brush removal, board walks, sidewalks that are the responsibility of the Town, emergency activities as such are authorized by the Town Board, and other activities involved with the care, upkeep and maintenance of highways and bridges of the Town.
- IB. PERMANENT IMPROVEMENTS HIGHWAYS. The sum of \$150.000.00 shall be set aside to be expended for the permanent improvements of Town Highways. The Town Highways that are intended to be improved include:
- a) On the highway known as <u>Stone Road</u> commencing at <u>a point 1 mile SW from Rte 28A</u> and leading to end of public maintenance, a distance of 1.2 miles. **Estimated Cost \$84.125.00**.
- b) On the highway known as <u>Hillcrest Avenue</u> commencing at <u>intersection of Old Route 209</u> and leading to <u>intersection with Altamont Drive and Cedar Street</u>, a distance of <u>.12</u> miles.

Estimated Cost \$9.000.00.

c) On the highway known as <u>Dug Hill Road</u> commencing at <u>Hurley Mountain Road</u> then continuing for a distance of 1.10 miles to the intersection of Reichel Road.

Estimated Cost \$85.000.00.

NOTE: This Agreement should be signed in duplicate by a majority of the members of the Town Board and the Town Superintendent of Highways. One copy must be filed in the Town Clerk's Office and one copy in the Office of the County Superintendent of Highways. COPIES DO NOT HAVE TO BE FILED IN ALBANY.

RESOLUTION # 1 Transfer of Planning Board Fees to Recreation Fund 20B
