WHEREAS, the Leachate Collection System at the former Town of Hurley Landfill has failed several times since the

### original closure, and

WHEREAS, the automatic system of pumps and sensors failed many years ago, and

WHEREAS, the previous two administrations failed to get professional assistance to make corrections to the failed pumps and sensors, and

WHEREAS, the evidence of the failure of the automated system is in delegating manual monitoring of the system, with stipends to highway department employees and subsequently, with no stipends to Transfer Station employees, and

WHEREAS, for years the manual monitoring of the broken leachate collection system consisted of leaving heavy metal lids open to the elements and measuring the level with a dipstick, and

WHEREAS, no proper training was conducted with town employees who were assigned the responsibility for

### monitoring, and

WHEREAS, the lack of training did not provide town employees with the resources to recognize mechanical and/or electrical failures in the system, and

WHEREAS, it has been determined that electrical and mechanical failures occurred which prevented the pumps from properly moving leachate into the system, and

WHEREAS, the lack of leachate collection pulls from the system was directly a result of electrical failure which did not move the fluids from the lower catch basin and tanks into WetWell #1 and Wet Well #2, and

WHEREAS, the former Supervisor hired WindRiver Environmental to repair the electric to the pump in the lower catch basin and replace the pump that failed years ago in Wet Well #2, and

WHEREAS, the pumps were hardwired into the electric without a high liquid level alarm being installed, and WHEREAS, the aforementioned work was performed without Town Board approval, and

WHEREAS, the work resulted in the system overflow of leachate onto the ground which resulted in a Notice of Violation by New York State Department of Environmental Conservation, now

THEREFORE BE IT RESOLVED to retain Crawford & Associates, Engineers to analyze the system, diagnose the problems and make recommendations for appropriate corrective action.

- The Town Board hereby declares itself Lead Agency for the purposes of environmental review with respect to the proposed local law, in accordance with Article 8 of the Environmental Conservation Law and the regulations promulgated thereunder at 6 NYCRR 617 (collectively, "SEQRA") and determines that the proposed action meets the criteria of a Type 1 Action under SEQRA.
- Directs the Town Clerk to post the draft local law and EAF Part 1 on the Town website, to place a paper copy on the Town Hall bulletin board and to post notice of the continued public hearing and local law in the Town online newsletter.
- This public hearing is hereby continued to March 8, 7:05 pm, and the Town Clerk is directed to post notice of said date in the Town's official newspaper.
