Town Board Business

1. Supervisor Bellows read the intermunicipal agreement for the used paver to be shared by the three towns.

This agreement, by and between the Town of Ulster, a governmental subdivision with offices at 1 Town Hall Drive, Lake Katrine, N Y 12449, hereinafter known as "Ulster", The Town of Woodstock, a governmental subdivision with offices at 47 Comeau Drive, Woodstock, N Y 12498, hereinafter known as "Woodstock" and the Town of Hurley, a governmental subdivision with offices at 10 Wamsley Place, Hurley, N Y 12443, hereinafter known as "Hurley", and entered into under the provisions of Article 5-G of the General Municipal Law:

Whereas, the Highway Superintendent if the Townships of Hurley, Ulster and Woodstock have consulted on the purchase of a used paver; and

Whereas, the Highway Superintendents agree that the purchase price for a used paver from Hoffman Equipment in the amount of \$52,700. is reasonable; and

Whereas, the Highway Superintendents unanimously recommend to their respective Town Boards that the three Townships enter into an agreement outlining terms for the purchase, use, storage and maintenance of the used paver; and

Whereas, the representative of the three Town Boards and their respective Highway Superintendents, and attorneys have agreed to terms for the purchase, use storage and maintenance of the used paver; and

Whereas, under the provisions of Article 5-G of the General Municipal Law the terms of this intermunicipal agreement are practical because the respective Townships have limited need for a paver, and therefore the agreed upon terms will benefit the taxpayers of the respective Townships by joint ownership of the paver and the sharing of costs to purchase, use, store and maintain the paver;

Therefore, be it agreed as follows:

- 1. Ulster, Woodstock and Hurley each agree to pay thirty-three and 1/3 percent (33.3%) toward the cost of purchase and maintenance of the paver, and to receive thirty-three and 1/3 percent (33.3%) of any proceeds generated by rental or sale of the paver.
- 2. The Highway Superintendents in each Town shall govern operation, use and housing of the paver, shall set a schedule for use of the paver, and shall designate the employees to be trained in the use of the paver. Only employees designated by the Highway Superintendents shall operate the paver.
- 3. The paver shall be housed the Town of Ulster Highway Complex when not in use by the other Townships party to this agreement, in which case the Highway Superintendents shall agree on where the paver will be stored. Existing levels of cooperation with the performance of roadwork among the three Townships may continue.
- 4. The Town of Ulster shall perform the necessary service on the paver to prepare it for use at the beginning of each paving season, and also to prepare it for winter storage at the end of each paving season.
- 5. Only qualifies mechanics employed by the Townships may repair, service and maintain the paver as directed by each Highway Superintendent. There will be no labor charges billed to other Townships for routine maintenance work on the paver when performed by mechanics employed by Ulster, Woodstock and Hurley. Costs for any and all parts to repair or maintain the paver, however, shall be divided evenly among the three Townships. The Highway Superintendents shall give prior approval for repairs or work not to be performed by the Townships, and after such approval, the costs incurred for labor & parts shall be divided evenly among the three Towns. If the repairs are due to negligence of the personnel of a Township in possession of the paver, that Township shall pay all costs.
- 6. The Highway Department finished with use of the paver shall clean, grease, and fuel up the paver for its use by the next Highway Department. The Highway Superintendent receiving the paver shall inspect it for defects, and report defects, if any, to the other Highway Superintendents.
- 7. If other municipalities wish to use the paver, unanimous agreement on terms among the three Highway Superintendents, and the approval of their respective Town Boards shall be required before such use is permitted. In all such instances, employees of the Ulster, Woodstock or Hurley Highway Departments shall operate the paver.
- 8. The three Townships agree that the cost of the purchase of the paver shall not exceed \$52,700. All three Highway Superintendents agree to submit no later the April 1 of each year to their respective Town Supervisor and Town Board a detailed accounting of the annual costs associated with the maintenance and repairs to the paver, and proceeds, if any, received for rental of the paver to other municipalities. If the total costs and / proceed are

not to be apportioned evenly among all three Towns, such accounting shall indicate the reasons thereof. Payments owed by one Township to another, if any, shall be paid no later then June15th of each year.

- 9. The Town of Ulster shall place the paver on its insurance policy and will name the Townships of Woodstock and Town of Hurley as loss payees. The liability exposure shall be borne by each town on their respective General Liability policy.
- 10. Any disputes concerning use of the paver not resolved by the Highway Superintendents of Ulster, Woodstock or Hurley regarding the paver shall be referred to the respective Town Supervisors for resolution. A majority vote of the Supervisors shall be required to resolve the dispute.
- 11. Termination of Agreement: Should either the Town of Ulster, Woodstock or Hurley elect to terminate this agreement, written notice to the other municipalities shall be given at least three (3) months prior such termination. Such notice shall be deemed to be that municipality's offer to sell its interest to the other parties. If neither of the other municipalities elects to purchase the interest of the terminating municipality, and there is no transfer of the terminating municipality's ownership to another municipality, or if all parties shall elect to terminate this agreement, then the equipment shall be sold according to the provisions of law regarding the disposition of such equipment. The net proceeds shall be divided on the basis of percent of ownership set forth in Section 1.
- 12. This agreement is entered into pursuant to the laws of the State of New York, and any changes or amendments to this agreement must be in writing and signed by all the respective Town Supervisors and Highway Superintendents upon authorization of their respective Town Boards

- <u>3.</u> Superintendent Russell submitted an amended agreement for the expenditure of highway moneys. Councilwoman Briggs read the agreement as follows.

Agreement for the Expenditure of Highway Moneys Section 284 of the Highway Law

AGREEMENT between the Town Superintendent of Highways of the Town of Hurley, of Ulster County, State of New York and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, the revenues from equipment rentals, reimbursement for snow and ice removal and other charges for services, the reappropriated funds, and the CHIPS and other State aid for highways, shall be expended as follows:

- 1A. GENERAL REPAIRS. The sum of \$350,000.00 shall be set aside to be expended for basic work and general maintenance and repairs upon 52.51 miles of town highways, including sluices, drainage ditches, culverts and bridges having a span of less than five feet, tree and brush removal, board walks, sidewalks that are the responsibility of the Town, emergency activities as such are authorized by the Town Board, and other activities involved with the care, upkeep and maintenance of highways and bridges of the Town.
- 1B. PERMANENT IMPROVEMENTS HIGHWAYS. The sum of \$300,000.00 shall be set aside to be expended for the permanent improvements of Town Highways. The Town Highways that are intended to be improved include:
 - a) On a street known as <u>Brucken Road</u>, commencing at <u>Morgan Hill Rd. going to end of roadway</u>, a distance of <u>0.5 miles</u>. <u>900 Tons of Binder</u>. <u>Estimated Cost: \$53,000.00</u>.
 - b) On a street known as <u>Dug Hill Road</u>, commencing at <u>Croft Rd</u> continuing to <u>Norbert Rd</u>, a distance of <u>0.75 miles</u>. 1,400 Tons Type 6 Blacktop. <u>Estimated Cost: \$99,000.00</u>.

- c) On the street known as <u>Griffin Drive</u>, commencing at <u>Ridgewood Ave and ending at Edgewood Ave</u>, a distance of <u>0.5 miles</u>. 1100 Tons Type 6 Blacktop. <u>Estimated Cost:</u> \$81,400.00.
- d) On the street known as <u>Hilltop Drive</u>, commencing at <u>Town Line continuing to Rayna Street</u>, a distance of <u>0.2 miles</u>. 400 Tons Type 6 Blacktop. <u>Estimated Cost:</u> \$29.800.00.
- e) On a street known as North Drive, commencing at State Route 375 and ending at Pine

 Tree Rd, a distance of 0.2 miles 400 Tons Type Blacktop Estimated cost:

 \$28,650.00
- f) On a street know as Normandy Court, commencing at State Route 375 continuing to end of roadway, a distance of 0.15 miles Estimated Cost \$45,000.
