### **<u>1. OLD TOWN BOARD BUSINESS:</u>**

(A) Supervisor Shultis reported that a court date has been set for NYC DEP' to challenge our tax assessment of their reservoir land. The court date is Aug. 13, 2007. We hope to get a resolution to some of the tax assessment cases

(D) On June 14<sup>th</sup> sixty three officials attended the Hurley sponsored Lower Esopus Estuary Grant meeting at the Holiday Inn. Representatives from federal, state, NYC and County government attended.

### 2. <u>NEW TOWN BOARD BUSINESS</u>:

•G Supervisor Shultis read a rough draft of the wording for Local Law #2 of 2007 also known as the "Level Three Sex Offender Residency Law". He said that he was still waiting for a list of bus stops from both school districts and asks that the Board review the law.

•G The Hurley Library has expressed interest in taking ownership of the Hurley Library building from the Town of Hurley. Supervisor Shultis said that he has no objections, but that the property would have to revert back to the town if it ceased being a library. If privately owned all repairs will be the Library's responsibility and not the residents.

•G The Sheriff Dept. work program crew is caulking and painting the Town Hall and park bathrooms for free. The work project requires Hurley to provide all supplies (such as paint etc.) and lunch for the workers. They have already provided 6 days of work and will return in 2 weeks to complete work.

WHEREAS, the application for the grant has been determined by the Town Board to be an Unlisted Action pursuant to the New York State Environmental Quality Review (SEQR) Act of New York State and Title 6, NYCRR, Part 617, Section 617.2 of the SEQR regulations; and

WHEREAS, the Town Board is the only "involved" agency for this action and is by default "Lead Agency" pursuant to SEQR

NOW THEREFORE BE IT RESOLVED, that:

The Town Board of the Town of Hurley, Ulster County, New York, hereby declares that the proposed action will not have a significant adverse impact upon the environment and renders a Determination of Non-Significance (Negative Declaration) pursuant to SEQR.

the extra week would only leave 3 days to complete the grant application.

Mike Kight (DEP) told Supervisor Shultis that work was scheduled to be done this week. Supervisor Shultis is also trying to have the area from Stone Rd. to the end of DugHill Rd. declared part of the Watershed.
