# **Town Board Business**

- 1. As you know we had a wonderful parade on Memorial Day. We received a proclamation from Gov. Patterson. Supervisor Bellows wanted to thank Debbie Oakley chairperson of the parade, Diana Cline chairperson of the Rec committee, Karl Bruckner for his donation and everyone who was down here helping out.
- 2. We have a meeting coming up in June for the West Hurley fire company. Mr. Gill has been in discussions with Joe Wisneski. The fire company was busy in May so we will be moving ahead on that issues.
- 3. The public access channel 23 is coming back. Supervisor Bellows would like a representative from the Town of Hurley for public access channel. If anybody is interested in being a representative please send a note in to the town clerk or supervisor.
- 4. Supervisor Bellows went to a meeting with the Ulster County supervisors and they discussed election costs. There is some indication that the legislature is committed to getting back to the towns by September and they will then let us know the approximate cost at that time and that is going to be very important to us.
- 5. We had a meeting with Mike Jordan who is representing the Town for the drainage project at Bristol Hill. We went through the easements and that was squared away and now is going to Mike Moriella who is going to type it properly and get it signed and complete within 10-14 days. Then we will have Briner and Larios draw up the bids.
- 6. Councilwoman Briggs said that the tennis courts at the Park are completely painted and they look great a nice green color. There are no nets or anchors up yet but they are coming. Our new director of the summer program has contacted people from KHS tennis and they are going to add that to our summer program.
- 7. The Hurley Rail Trail Mixer will be Sat June 6 from 9 to 1

- 8. We had a Public Hearing for the MS-4 annual report tonight at 6:00
- 9. We had some discussions with Mrs. Manly about an issue on Russell Road and the town board is committed to Mrs. Manly that we will be stepping it up with the UC Health Dept and town engineer to help that situation which is ongoing.
- 10. There will be an OWB workshop on June1 at 5:00 PM
- 11. We were asked by Paul Economos who is representing the Leterskys to refer this to the Planning board. Supervisor Bellows felt that possibly the town board would consider this tonight. The letter from our attorney stated the town board will have the final say on this. The Town Board agreed and Supervisor Bellows made a motion to refer this to the planning board.
- 12. We heard from our attorneys out of Latham Hacker and Murphy, LLP, they are representing us in our lawsuit with the NYC DEP against the town regarding the assessments. There is a good chance we will be hearing from Judge O'Connor in the next 60 days.
- 13. The Town Board was given a sheet to look over about the divider for court. Since we are not in a financial position to buy a little building for them it should go as high as it can. We'll scan the internet and see what the best prices are and try to get 3 comparisons.
- 14. The Hook and Walnut easements had been held up because a resident had passed away and a house was sold. We are looking in about 10 days to set a meeting up and have the home owners come in to sign and have notarize the agreements.
- 15. Supervisor Bellows mentioned last meeting we are going to get Ruth Watera who is the chair person of the Comprehensive Plan to get together with a member of the Zoning Revision Committee.
- 16. Tom Schneller has asked to work on the blueberry trail in the West Hurley town park. He wants to make sure the dead material is taken away. He is a member of a mountain bike group who originally made the trail and would like to work on that at no cost to the town. This would be good for the town.
- 17. The Ethics committee met on May 9 and there were no issues that were brought up for town board. There were a couple outstanding documents to be signed and they have been mailed a letter asking them to come in and sign off.
- 18. Supervisor Bellows met with Cornell Coop extension and they talked about stream management of the upper Esopus. The upper Esopus touches the lower they thought they should get some of the towns from the Lower Esopus involved. In essence what we are going to do is write up a little narrative and submit to them a) we want to be a part of this and b) that there is money available and one of the suggestions made is that there is the potential of getting some money for berming to cut down on flooding in the town.
- 19. June 10<sup>th</sup> is sign up for summer Rec program 7-8:30
- 20. At the supervisor's meeting there is a new/improved website called sunlightny.com. There's good information there.
- 21. The agreement of Expenditures for Highway monies and permanent improvements
