#### **TOWN BOARD BUSINESS**

1. Supervisor Bellows received notification from the Ulster County that we are in need of a public hearing in the month of June regarding our participation in the MS4. The Town Board will get the documentation and we'll have a public hearing in the month of June.

2. There was a meeting of the Lower Esopus Group that councilwoman Hyman attended. Basically it was to review the DVD that was done of the Esopus from helicopter. It is being edited to put on the Town website so that everybody can look at it and it gives a very good view. The next stake holder's meeting for the Lower Esopus is on June 19. It is open to anybody that is interested. It's primarily to do with flooding and mitigating the flooding. There is also a meeting on June 10 which is at the Rosendale Recreation Center and it's about the flooding of two watersheds Rondout and the Esopus.

3. We have a meeting scheduled for Thursday at 6pm and this will be a public hearing on the zoning revision committee and basically this is just taking the current zoning that we have and there are some typos or incomplete information that should be added. Some names were mentioned in the body of the zoning and then left out of the chart so that when you refer to the charts it's not in there. This is the zoning revisions committee recommendations to the Town Board and then we're going to read them out so that we can comment.

4. Supervisor Bellows mentioned at the agenda meeting that there was a letter in the freeman about that the City of Kingston. It wasn't quite what Don Wade from Miami, FL had thought it would be. He was told to come and visit historic Kingston. "I also visited Hurley that I thoroughly enjoyed it, Hurley was simply clean and beautiful" so that was really nice to have him put in that little extra at the end of his letter about Hurley.

She wanted everybody to how grateful she was to be picked. Supervisor Bellows wanted to specifically thank Deb Oakley who for a first year taking over for Viola did a tremendous job and also thank the Rec dept.

6. National Trails Day is coming up on June 7<sup>th</sup> from 10-2 on our trail.

7. There is an Ulster County non-motorized advisory committee meeting on June 10<sup>th</sup> at 5:30 at New Paltz Boces for any town board members who want to attend.

8. We have received a 50C charitable organization called northern Ulster dollars for scholars and they are going to have a scholarship awards dinner on June 8<sup>th</sup> at the New World Home Cooking and that is going to be the Onteora High School Class of 2008 distinguished student award. It says available to any college bound student graduating from Onteora High School in June 2008. The cost of dinner is \$50 and \$25 for students and the money goes towards awards for next year.

9. Councilman Gill commented on the drainage. We're still waiting on Mr. Darwak to get the easement out there on Hook and Walnut. We going to have to get to together with the County and look at Zandhook and then we have to look at Orchard Street. Brinier and Larios are working on Birch and Braun St. and we have a little job to do on 75 Cedar Street, a half-day's work.

10. There was a workshop held by Sen. Bonasic in the Town of Ulster for the flood buy out program. Not only is \$2 million way short of an amount of money because just in Hurley we have 14 homes that have the Esopus run through them. The qualifications are your house has to be worth \$250,000 or less, second combined income for the family if you have 2 children is 107,000 that's the most that you can make to qualify for the program. They're not going to start off at the \$250,000 level. They are going to start at the lower level because when a flood goes through a mobile home it really wrecks havoc. The program is a good program and maybe if it works out well this year next year the governor will see fit to put more money into it.

12. Sales tax revenue for the Town of Hurley from March 1<sup>st</sup> to May 31<sup>st</sup> was \$31,945.88

13. There was a meeting on the shared municipal services within the county. Several of the towns have joined in to see how we can lower costs for all taxpayers. There is a booklet which we will circulate within the Town Board and Highway Superintendent.

14. Williams Lane update: Our town attorney only had one piece of paper from this case. The previous town attorney did not turn over the files that he had been working on so we have a phone call to the former attorney asking for him to drop off the files to the town hall. At this point the planning board and zoning board has been able to piece in a couple of the pages and we are looking forward to receiving that file back so we can help Mr. DeSantis.

15. Councilwoman Hyman went to a meeting of the Town Supervisors along Route 209. There's a grant that has been in effect for the last 2 years for \$500,000 to start studying Route 209 and how it can be developed in to a destination spot. Its just starting up again, as it has been dormant for a while. Part will be traffic study the other being zoning...it'll definitely be something where businesses will be encouraged to be on route 209 but there will be very strict guidelines as to what the business look like. It's a great program.

Dave Baker gave the Town Board a 400<sup>th</sup> Anniversary explore NY pamphlet. He read the benefits for the town to belong to this explore NY 400Community program. 1.)To be listed on the Explore NY 400 website and promotional material. 2.) To receive a 3x5 flag from the Quadra-centennial Logo and official certificate and Quadra-centennial Poster. 3.)Have permission to use the Quadra-centennial Logo on our website. Community responsibilities—1. Adopt an explorer NY 400 community resolution and submit it to the HFCQ Commission 2. Establish a 2009 planning committee to coordinate efforts. He recommends that the Town Board seriously consider it. The Stone House Day committee has already met on it; they are very interested.
