Discussion of the Town Budget:

1. Councilwoman Horner: The budget line 8161.4 for the leaf pick-up was \$52,500 but that was for 2-year contract and we could change that to \$27,000 plus \$5,000. for extras and reduce that line to \$33,000. We would save \$19,500.

2. Councilwoman Hyman brought up in house bookkeeping to save on that budget line. She proposed the following resolution.

Supervisor Bellows felt that in house bookkeeping does not provide the checks and balances needed for such an important job.

3. Supervisor Bellows said that the budget line for Social Services 6140.4 should be raised due to the hardships a lot of people. The past couple of months there has been an increase \$8,000 for last bill and\$11,000 for the current bill. Margie Holzman is looking into the charges. We currently have \$20,000. in that budget line. Supervisor Bellows recommended we raise the budget line to \$100,000. This amount would raise the budget to about 10%. It was Supervisor Bellows suggestion to take \$50,000 from the Highway permanent improvements DA 5112.2 and put into home relief. It was finally decided to put the \$50,000. in the contingency budget line to use for home relief if needed and \$19,500. from the 8161.4 to raise 6140.4 to \$39,500.

Resolution # 2008-165 Offered by Councilwoman Hyman Secretary/Bookkeeper position Seconded By Councilwoman Horner

WHERAS, it is the goal of the Town of Hurley Board to make sure operations within the town are done as effectively and efficiently as possible to save taxpayer dollars, and

WHERAS, the Town of Hurley currently out sources its monthly bookkeeping duties at a cost of over \$42,000 per year, and

WHERAS, the Town of Hurley Town Board unanimously voted for the purchase of the software and a computer system at the cost to taxpayers of \$20,000 and

WHERAS, performing the monthly bookkeeping duties in house instead of out sourcing will save the town over \$20,000 per year and supply the Financial Officer with up to date information on the first of each month instead of 3 weeks late as is the current situation,

THEREFORE BE IT RESOLVED TO, create the position of full time Secretary/Bookkeeper non competitive position at the pay rate of \$12.50 hourly, and

BE IT FURTHER RESOLVED TO, instruct the Town Supervisor to file a new Position Duty Statement Request with the Ulster County Civil Service Department

asking that the position of Secretary/Bookkeeper non competitive be created for the Town of Hurley, and

BE IT FURTHER RESOLVED TO, hire a competent worker to fill this position and receive training from the software provider to use the current Accounting Program and computer system already owned by the town and complete all bookkeeping duties in house, and

BE IT FURTHER RESOLVED TO, retain outside accounting services to audit town books each fiscal quarter as needed.
