

WHEREAS, the Town of Hurley is a New York State-designated Climate Smart Community and is committed to preserving and protecting our natural environment; and

WHEREAS, the Town and its residents produce a large amount of solid waste, much of which is organic waste, which is a leading source of greenhouse gas and is one of the heaviest and costliest forms of solid waste to dispose of; and

WHEREAS, the Town of Hurley issued Request for Qualifications ("RFQ") dated July 7 2023, inviting interested respondents to submit proposals for a "Zero Waste Solid Waste Management System" ("ZWS") during said period; and

WHEREAS, draft RFQ copies were made available to interested parties in the Hudson Valley region prior to its formal release; and

WHEREAS, there was a 60-day comment period following the distribution of the draft RFQ but no comments were during this period and no substantive adjustments were made to the RFQ; and,

WHEREAS, the final RFQ was released on July 7, 2023 and made available to all interested

parties that requested copies of the RFQ; and

WHEREAS, in accordance with the provisions of Section 120-w of the General Municipal Law, the draft and final RFQs were advertised state-wide and locally, as follows: New York State Register, New York Environmental Notice Bulletin, Daily Freeman, Hurley Public Library, West Hurley Public Library, and on the Town's Website; and

WHEREAS, the Town of Hurley only received a single proposal from Greenway Environmental Services of 205 Hurds Road, Clintondale, New York, 12515 in response to the RFQ; and

WHEREAS, a form of agreement for services with Greenway Environmental Services ("Contractor") has been prepared and presented to this Board, a copy of which is on file with the Town Clerk (the "Agreement"); and

WHEREAS, it would be in the best interests of the Town to engage the Contractor and proceed with the Agreement.

NOW THEREFORE BE IT RESOLVED, by the Town Board of the Town of Hurley, as follows:

- 1. The Town Supervisor is hereby authorized and directed to execute the Agreement in substantially the form on file with the Town Clerk, with such changes as shall be approved by such officer and which do not affect the substance thereof.
- 2. The Town Supervisor, the Town Clerk, and the Town's other officers, employees and agents are hereby authorized and directed for, and in the name and on behalf of the Town, to do all acts and things required or provided by the provisions of the Agreement. 3.
