## **Town Board Business**

- 1. Meredith Taylor from the Catskill Center for Conservation and Development spoke to the Town Board about a grant she is applying for. The property they acquired located on Walton Lane would be developed into a public access recreation park. Under the requirements for these programs they must obtain approval from the governing body of the municipality in which the project is located. She did commit to keeping the Town Board updated on the progress of the project.
- 2. Public Hearing for Preliminary 2012 Budget will be November 2 at 6:00 PM at the Town
- 3. The Fema Application for the Highway has been mailed.
- 4. Solar panels for Town Hall are still in the working stage. We will be meeting with NYSERDA and getting specs. Whatever money is left would go towards the highway
- 5. The tree work that needed to be done at the Old Cemetery was awarded to LA tree service. They will be finished with the work by Tuesday.
- 6. The roof at the Town Hall needs to be repaired and the two bids we received were from A-1 Windowing and Siding for \$1465. and Scott Roofing for \$780.00. The Town Board agreed to award the job to Scott Roofing.
- 7. UCRRA has a compost bin on display at the Town Hall. The cost is \$60.00. The bin is available at UCRRA.

- 8. State aid we received is \$47,171.00 a small drop from last year.
- 9. Supervisor Bellows receive an article from Land Trust called Leave it on your lawn. It talks about leaf management plan to help reduce the amount of leaves entering the landfills. More info can be found at the Town Hall or the website www.kingstonlandtrust.org
- 10. We have one opening on the Ethics Board and also need to replace the two alternates.
- 11. We have received the resignation from Donald Beesmer who has served on the Planning Board for many years. If anyone is interested in serving on the board send a letter of interest to the Town Supervisor or Town Clerk.
- 12. The Lower Esopus Watershed Partnership group works to negotiate with the DEP. The newest is a release protocol to keep water at 90% during a certain period of time. They have a meeting scheduled for Thursday with the DEC and DEP.
- 13. Ulster County Probation Dept asked the town to submit a list of any jobs that might be needed at the town for community service workers.
- 14. We received several bids for the new boiler at the highway garage. There seemed to be a big difference in the bid amounts. We need to have an evaluation done at the garage to determine the right size boiler needed to heat the building and then we can estimates for the same equipment from each supplier.
- 15. We will be moving ahead with Kenozia Lake emergency culvert replacement. It will be put out to bid by Brinnier and Larios.
