Town Board Business

1. The Public Hearing was held for the Amended Ethics Local Law. The terms limits were adjusted to read consecutive service in the Ethics Board shall not exceed two complete three years terms. The resolution passed since there were no objections.
2. The court received a grant for renovations and one contract was painting two wall of the courtroom. The town Board felt that since the court uses the entire room during court that the entire room should be painted. Councilwoman Horner contacted Judge Parker to discuss painting of the entire room. with the grant. She was waiting to here back from him.
3. Councilman Gill is waiting to here back from Dave Corrigan about the Rail Trail Plaques.
4. According to the Public Access seven towns are responsible for the public television funding. We will set up a meeting to discuss this after the documents are forwarded to our town attorney to look over.
5. We received a letter from the NYC DEP projects planned along Route 28, resurfacing Coldbrook Road and also working on S curve on Coldbrook. They hoped that Spillway Bridge will be completed in Oct of 2010 and Stone Church bridge be completed in Oct of 2011. If anyone have any question or concerns about the projects they can be reached at 340-7800.
6. With the town leaf pick-up discontinued we still would like to encourage people to mulch their leaves or take them to the transfer station in paper bags. In the spring we will look for feedback from town residents good and bad on how the mulching went.
7. We will be looking at some drainage projects for 2011. Continuation of Rolling Meadows and Heintz property on Route 28A

8. Good news from the Valley group that our insurance was reduced by \$10,000.
9. We had a request about bake sale on elections day. Since Myer PTA has already been approved and have done in the past the town board thought they should be the only ones to have it here.
10. UC Planning Board sent out a questionnaire a few months ago. Greenway Compact Plan is about looking into the future. The town board will discuss it at the Nov. meeting.
11. The idea from most on the Town Board for the Central Catskill Collaborative byway was putting up a kiosk on Route 28 at the old gas station. We still need to talk to the owners of the gas station and discuss how the entrance and exit would work.
12. The town attorney will be putting together the Local Law for Dog Licensing. When that is complete the town board will set the public hearing.
13. Anyone wishing to enter the Crummy Creekside Culvert Contest can get more information and entry forms at www.ashokanstreams.org/culvertcontest.html. Deadline is November 30th.
14. Maverick Road reduced speed limit request has been sent to the state for review.
15. ZBA chairman, Code enforcement officer Hoffstatter and the town attorney will get together to discuss the steps to follow during ZBA meetings.
16. The town board felt that the Dog Warden request for a town cell phone was not necessary and the phone in her home was sufficient for her to be reached.
17. Halloween Curfew will be 7:30 pm for children under age 18 unless accompanied by a parent.
18. Ghost Walk by the Hurley Heritage Society will be Friday Oct 29th at 7:00 pm on Main Street.

From the Departments

1. Councilman Gill talked bout the Stream Management resolution that we need to pass in order to eligible for the funding and training. He thought the highway did a great job paving Dughill and wanted to find out the total cost for the job.
2. Councilman Zell said that maybe the board should appoint a committee for the 350th anniversary celebration.
3. Code Enforcement office Hoffstatter said that the town did well on the MS4 Audit. There were a couple issues of concern. The wash station at the highway and the original Local Law passed needed to be reviewed by the town attorney. He is still waiting for the final report.
4. Highway Superintendent said the amount for paving Dughill was about \$138,000.
