TOWN BOARD BUSINESS

- 1. Lions Club project to put new light on the town Christmas tree is ready to go Ron Shields introduced Carlo Castiglione to give a little history of the Hurley Lions Club. The Lions Club here in Hurley is part of the Lions Club International which is the world's largest service organization. They have 1.3 million members in 45,000 clubs in 202 countries. Lions are men and women who volunteer their time for humanitarian causes. The club was founded by Melvin Jones in 1917 and the clubs motto is we serve. They provide an emphasis on the blind and visually impaired. Based on a charge that Helen Keller gave the Lions international people in 1925 where she challenged them to be knights of blind and to help eliminate blindness throughout the world. In addition they recycle eyeglasses. They have a strong commitment to you and the communities that they serve. There sight first program was established in 1990 we are now into our sight first II campaign and as of the end of June 2008 around the world we have a goal of raising \$150 million and we exceeded that goal. We are preventing blindness around the world and we are very proud of that. The Hurley Lions Club was chartered in 1955. This is there 54th year of service to the Town of Hurley. They are a small club of 21 members. Our club annual dues are \$80.00 for the privilege of volunteering their time to serve our community. Every dime they raise must be spent on our charitable works. The gazebo is probably the single biggest project that a small Lions Club has ever completed.
- 2. Route 209 road project should be completed the first week of October.

- 3. Supervisor Bellows received a letter from UC transit. They are looking for park and rides lots to be able to use during winter. He suggested that the town hall lot would be a good for people to be able to ride share during the winter and they was very excited about that. We'll be waiting for more communication and finding out where the bus stops are going to be.
- 4. We will set the curfew for Halloween at the October Agenda meeting.
- 5. Supervisor Bellows spoke with NY Rural Water Association and have worked out a payment program that was acceptable to the state comptroller, to them and to the Town of Hurley it will be paid in 2 installments. They will be sending a corrected copy which was signed off on. They should be starting on the West Hurley water study soon.
- 6. We had some conversation with Mr. King up on Route 28A. There is a big problem with drainage in his yard. The Town of Hurley, County of Ulster and the DEP all saying it's the other person's problem. Superintendent Russell went up and chatted with Mr. King to get more information. We probably will see something done in the springtime.
- 7. The NYS DEC will be having a collection of pesticides. Colleen Darcy is the local representative. We'll post this brochure Clean Sweep Fall 2008. This program will run from November 3. There is a website cleansweepnewyork.org and the telephone is #877-793-3769.
- 8. Wally Cook has sent a letter to the Town Board mentioning that as of the end of the year he will be stepping down as rail trail chairman and they have talked with their committee and they are recommending Heather Hirsch as the next chair.
- 9. The town newsletter should be hitting your mailboxes soon. The Winter Watch flyer will be in the newsletter with names, addresses and numbers on where to get help this winter for your heating.
- 10. The Hurley Library survey has been completed. It has been mailed to our attorney Jack Darwak to review.
- 11. Supervisor Bellows received a letter from the union representing our highway and they have asked him to sign off on a memorandum of agreement. This is where the group is looking to account for their sick days starting at the beginning of the year versus earning them all through the year. The Town Board agreed to have Supervisor Bellows sign the agreement.
